

Call for Papers, Posters, and Organized Sessions 83rd Annual Meeting of the Rural Sociological Society Theme: Rurality and Crises of Democracy

### Deadline: February 3, 2020, 11:59 PM CST

After the 2016 U.S. Presidential Election, rural voters assumed a new importance in national debates, one that underscored both their historic importance and the extent to which they had been misunderstood and overlooked by urban America. These social and political dynamics have not been confined to the United States. In Europe, populist and nationalist movements from Britain, to Poland, Hungary, Germany and France, have claimed rural voters and the countryside, and posed increasing challenges to the integrity of the European Union while simultaneously fomenting xenophobic and anti-democratic sentiment. Similar dynamics are evident in Turkey, the Philippines, Thailand, and elsewhere. As the 2020 US Presidential Election approaches, and especially in the wake of populist movements elsewhere across the globe, questions of spatial inequalities and ideological differences demand not punditry, but scholarship. This meeting's theme brings our scholarly practice to questions of rural agency, the social, political and economic roles of rural communities, and how crises of late-stage capitalism play out unevenly across the rural/urban divide in ways that both highlight and distort the challenges rural people and places face. The Rural Sociological Society was convened in 1937 at a similarly turbulent time in world history, and then as now, it is through the patient, committed and rigorous scholarship that such upheaval can most clearly be understood, and navigated. This historical juncture represents an important moment for the theoretical, empirical, and applied contributions rural sociologists can make to unpack the contradictory realities of rurality, rural identities, spatial inequalities, the implications for democracy, and ultimately, the well-being of rural people and places.

The Rural Sociological Society (RSS) and the Committee on Diversity are pleased to announce that travel awards are available to support the attendance and participation of minority participants at the annual conference to be held in Westminster, Colorado. These awards will be awarded on a competitive basis and are meant to assist participants in defraying costs associated with attending the RSS meeting.

We anticipate granting awards at the minimum amount of \$500 per recipient or at a maximum amount of \$750; however, the amount of funds and the number of awards may fluctuate depending on the number of applications and the need described therein.

# Eligibility and Application Requirements To be eligible for the award, an applicant must be:

 An active participant of the meeting by presenting a paper, participating on a panel, or presenting a poster on research. We encourage applications from academics and non-academics.

## In addition, for students:

- A student pursuing a degree relevant to rural studies in an academic institution.
  - A student member of the Rural Sociological Society at the time of receiving the award.

## To apply, an applicant must submit:

## Research and Interest Group (RIGs) - 2020 Student Paper Award

What are Research and Interest Groups? Research and Interest Groups (RIGs) reflect the substantive interests of Rural Sociological Society (RSS) members and serve as an important avenue for connecting members with similar interests. RIGs serve a critical role in RSS including: identifying, developing, and recruiting for the annual RSS conference; planning special events, speakers, field trips for the annual conference; providing intellectual leadership in their respective areas; rewarding achievement through internal awards and recognitions; and creating opportunities for members, particularly graduate students, to network and identify colleagues with similar interests.

## General Guidelines for Submitting Student Papers:

Be sure to read carefully the requirements set by each RIG when submitting your paper for consideration for a student paper award

- Is authored by a student or students (no faculty co-authors).
- Authors are members of the Rural Sociological Society.
- The paper may be under initial review at time of submission to a peer-reviewed journal but cannot be already accepted (in press) or published in a peer-reviewed journal.
- Students may submit the same paper to more than one RIG for consideration but it must have topical relevance and fit the criteria for each RIG.
- Students are expected to present their paper at the Annual Meeting.

**RONALD WIMBERLEY STUDENT PAPER COMPETITION** (Graduate and Undergraduate)

Submission Deadline: Friday, April 3rd, 2020

The Community, Health, and Family Research Interest Group (RIG) is proud to announce the seventh annual Ronald Wimberley student paper competition designed to encourage and support graduate and undergraduate student research on rural communities. The call for papers is open to a wide range of topics in keeping with the spirit of the award's namesake, Ronald Wimberley. Emphasis should be placed on the improvement of the quality-of-life in rural communities. Preference will be given to those papers that make a strong contribution to our understanding of rural community life and health. How are rural communities adapting to challenges brought about by scientific changes, economic transformation, or health needs?

### **Graduate Student Paper Competition Guidelines:**

Papers submitted for this competition will be held to a high standard with respect to the level of scholarship. The length of the paper should range from 20-30 pages and should include a relevant review of the literature, original analysis, a clear discussion and set of conclusions, complete references, and be written at a professional level.

### **Undergraduate Paper Competition:**

Papers submitted for undergraduate student paper competition will be similarly held to a high standard appropriate to the level of undergraduate scholarship. The length of the paper should range from 10-20 pages and should include a relevant literature review with complete references that is clearly and legibly written. Papers that include original analyses will be rated higher, but this is not a requirement for submission.

\*Manuscripts may be co-authored as long as the student submitting the manuscript is the primary author.

#### **Instructions for Submission:**

To have a paper considered for review for this award, first, submit an abstract to present the paper at the 2020 annual meeting of the Rural Sociological Society. Second, submit your manuscript as an attached Word (doc. or .docx) file to Dr. Karl Jicha at <a href="kajicha@ncsu.edu">kajicha@ncsu.edu</a> by Friday, April 3, 2020. Please do not submit your paper in .pdf format, as we will need to edit them to make judging anonymous. In the subject line of the email enter "submission for graduate" or "undergraduate student paper competition." When the submissions are received, they will be sent to a panel of judges. Winners of the paper competition will be honored at the RIG reception during the RSS annual meeting, where they will receive a certificate and their award honoraria (see below). Winners will be notified via email by June 1, 2020.

### Deadline for submissions: Friday, April 3rd, 2020

**Honoraria:** Graduate Paper (\$250.00); Undergraduate Paper (\$150.00): to be used to defray part of the cost of registering for and attending the 2020 RSS Annual Meeting in Westminster, CO.

#### NRRIG GRADUATE STUDENT TRAVEL SCHOLARSHIP

The NRRIG Graduate Student Travel Scholarship is intended to support graduate student participation at the RSS annual meetings.

The recipient will be reimbursed for the student (member) registration cost for the RSS annual meeting (\$125).

There is a two-step process for submission: 1) Submit an abstract to present an oral presentation in the area of environmental or natural resources sociology at the annual meeting; 2) submit a cover letter to the NRRG chair (Cat Edgeley at <a href="mailto:catrin.edgeley@nau.edu">catrin.edgeley@nau.edu</a>) by <a href="mailto:May 4">May 4</a> of the year of application. Cover letters will be reviewed based on need (i.e., does the student have alternative funding sources via his/her department or advisor), and importance of the meeting to the student's career trajectory. Abstracts will be evaluated based on relevance, innovation, and/or potential contribution to the NRRIG. The winner will be selected by a committee of NRRIG members and notified by <a href="mailto:June 1">June 1</a> of the year of application.

#### NRRIG GRADUATE STUDENT PAPER AWARD

The Natural Resources Research Interest Group (NRRIG) of the Rural Sociological Society is soliciting submissions for a graduate student paper award in the area environmental or natural resources sociology. The paper should be related to the broad interests of the NRRIG. Current graduate students and recent graduates (who receive their degrees no earlier than May of the year of award) may apply.

Coauthored papers are acceptable, including those co-authored with faculty. If co-authored, the applicant (a) must be the lead author of the manuscript, and (b) provide a statement detailing the relative contributions of each co-author.

The recipient will receive a monetary prize of at least \$100 (final amount TBD based on NRRIG budget) to defray the cost of attending the Annual Meetings of RSS. The recipient will also be recognized at the NRRIG business meeting.

There is a two-step process for submission: 1) Submit an abstract to present the paper at the 2020 meeting; 2) Send an electronic copy of the full paper with contact information to the NRRIG chair (Cat Edgeley at <a href="mailto:catrin.edgeley@nau.edu">catrin.edgeley@nau.edu</a>) by <a href="mailto:May 4">May 4</a> of the year of application; and (3) if co-authored, provide a statement detailing the relative contributions of each co-author.

The paper submission should not exceed 35 double-spaced pages (including all tables, graphs, and references) in a standard font (12 point). The winner will be selected by a committee of NRRIG members and notified by **June 1** of the year of application.

Papers will be evaluated using the following criteria:

- Advancement of knowledge in the area environmental or natural resources sociology.
- 2. Significance of the topic for the NRRG of the Rural Sociological Society.
- 3. Quality and implementation of the research, theory, and argument.
- 4. Analysis and interpretation of the findings.
- 5. Clarity and organization of the writing.

#### NRRIG WILLIAM R. FREUDENBURG AWARD OF MERIT

The William R. Freudenburg Award of Merit is presented to recognize exceptional contributions to the sociology of natural resources and the environment. The award is given to recognize an outstanding legacy / collective body of work that has demonstrably impacted natural resources and environmental sociology.

Recipients will have the following qualifications: outstanding research and scholarship as evidenced not solely by numbers of publications, but their impact: simply put, we are looking for recipients who have substantively affected the trajectory of thinking within natural resources and environmental sociology. Such impact may also be evidenced via application of work beyond the academy, such as work with a natural resources agency, organization, or other partnerships. Other contributions to the NRRIG or sociology of natural resources and environment, such as an outstanding legacy of outreach, graduate student mentorship, and/or instruction are also envisioned as important criteria for consideration. # UKCPR Announces Second Round RFP for Research on Senior Food Hardships

The University of Kentucky Center for Poverty Research (UKCPR), with underwriting from the Food and Nutrition Service (FNS) in the U.S. Department of Agriculture, announces a second round competition for research contracts that expand understanding of, and the attendant policy implications for, food-related hardships among older persons in the United States. For purposes of this RFP, older persons are defined as those ages 60 and older.

We seek research proposals from qualified individuals and institutions to provide rigorous research in one of three topical domains: 1) Describing households with food insecure seniors, including, but not limited to, factors

such as functional status and ability to live independently, access to transportation, mental function, spousal health status, and social network and family connections; 2) Understanding factors underlying participation and re-certification in food assistance and other safety net programs; and 3) Evaluating the causal impact of food and non-food assistance programs on health and nutrition outcomes, as well as related outcomes such as consumption trade-offs. Total anticipated funding under this mechanism is \$1.2 million of four large subcontracts at \$250,000 each and four small subcontracts at \$50,000 each.

The POLARIS, or Pursuing Opportunities for Long-term Artic Resilience for Infrastructure and Society, is a newly funded NSF project that studies environmental migration, food security, and human-environment conflicts in coastal Arctic Indigenous communities and identifies the important assets (social, environmental, infrastructural, institutional) to help them
